**Biogen Idec Inc.'s Annual Meeting of Stockholders will be held at Biogen Idec Inc., 15 Cambridge Center, Cambridge, Massachusetts 02142, on June 12, 2013, at 9:00 A.M. (local time).**

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote **FOR** the election of all of the director nominees; **FOR** Proposals 2, 3, 4, and 5; and **AGAINST** Proposal 6:

1. Election of Directors. The twelve director nominees numbered 1 through 12 are standing for election (to serve a one-year term).

4. To reapprove the material terms of the performance goals under the Biogen Idec Inc. 2008 Performance-Based Management Incentive Plan for purposes of Section 162(m) of the Internal Revenue Code.
5. To reapprove the material terms of the performance goals under the Biogen Idec Inc. 2008 Omnibus Equity Plan for purposes of Section 162(m) of the Internal Revenue Code.
6. Shareholder proposal regarding adoption of a share retention policy.

We may also act upon such other matters as may properly come before the meeting or any adjournment or postponement thereof.
